is a teacher as defined in Ind. Code 20-18-2-22.


In exchange for the Teacher's services described below, the Corporation and the Teacher agree that:


1. The Teacher shall teach in the schools of the Corporation for the school term, beginning 07-01-20, and ending on 06-30-22. Ind. Code 20-28-6-2(a)(3)(A)
2. The school term described in paragraph 1 immediately above for services under this Contract consists of 218.00 days. Ind. Code 20-28-6-2(a)(3)(B)
3. The number of hours per day the Teacher is expected to work under this Contract is N/A. Ind. Code 20-28-6-2(a)(3)(E)
4. The Corporation shall pay the Teacher for services under this Contract the total salary of \$93,921.00 during the school year. Ind. Code 20-28-6-2(a)(3)(C)
5. The Corporation shall pay this amount in 25 installments on a Biweekly basis. Ind. Code 20-28-6-2(a)(3)(D) Ind. Code 20-28-6-5(1)
6. This Contract may be cancelled during its term for any of the grounds set forth in Ind. Code 20-28-7.5-1(e) pursuant to the procedures set forth in Ind. Code 20-28-7.5-2 and Ind. Code 20-28-7.5-3.
7. This Contract is a public record pursuant to Ind. Code 20-28-6-2(d) and Ind. Code 5-14-3.

CONTRACT FOR NON-TEACHING EMPLOYEES

This EMPLOYMENT CONTRACT entered into by and between Richard Fields (hereinafter referred to as First Party), and NOBLESVILLE SCHOOLS in HAMILTON COUNTY, INDIANA, (hereinafter referred to as Second Party),

WITNESSETH THAT:

1. The First Party is hereby employed a Athletic Director by the Second Party and is to perform employment duties at the Middle School building or wherever First Party may hereafter be assigned by Second Party. (ECA Code # _____)

2. The period of employment shall be for a period commencing on the 1st day of July 2020 and ending on the 30th day of June 2022 (209 days per year)

3. In consideration of this employment the First Party as an employee agrees to comply with all reasonable rules and regulations promulgated by the officials and designated supervisors of Second Party for whom the First Party may be performing employment services as well as the customary requirements of that particular position for which employed.

4. In consideration of the employment and for the performance of duties and responsibilities of First Party to Second Party under is employment agreement, the employee shall be paid the annual sum of \$89,857.00 during the period of this contract of employment.

6. This contract of employment may be terminated at any time by either party upon giving notice to the other party.

7. In the event of dispute as to duties and responsibilities of the employment between the parties, then Second Party's determination as to such duties and responsibilities shall be final.
